The seven year proposal for the write-in Student Edition is not to exceed \$134,000, discounted from \$291,019.04. The proposal also includes extensive teacher support materials, online student and teacher editions, online intervention, STEM lessons, and Inquiry Skill activities. This is a general fund expenditure.

## 12-147 Adopt Algebra Series

That the Twinsburg Board of Education adopts and purchases **Holt McDougal (HMD) HMD Burger Algebra 1** c.2012, a new series for Algebra 1, as recommended by the District Curriculum/Technology Committee. The 375 copies of the hardback student editions are not to exceed \$34,000, discounted from \$63,485.25. The proposal also includes extensive teacher support materials, online student and teacher editions, intervention and enrichment activities. This is a permanent improvement fund expenditure.
