Dear Twinsburg Schools Family:

Today, I reporting the following COVID-positive case to Summit County Public Health officials:

One (1) On-Campus 4th grade student

Thanks for continuing to encourage your children and each other to practice the COVID-19 safety protocols of wearing a mask, keeping socially distanced from others, and frequently sanitizing hands and/or frequently washing them with soap and water.

More than 1700 families provided feedback regarding the 2021/2022 school year through the survey in March. Our team has been analyzing your feedback along with the feedback provided by our students in grades 6 – 12, our certificated staff members and our classified staff members. During the Board of Education Meeting tomorrow evening, I will provide a first glimpse of the feedback as it relates to our On-Campus vs. Twinsburg Virtual Academy options, feedback regarding the District's social distancing protocols, and feedback regarding student seating on our school buses.

Also, the Parent Survey and the Student Survey asked for feedback regarding Prom. Here are the results from our Senior Parents and our Class of 2021:

With six (6) students per table and significant space between students, 216 students could attend Prom. The senior class has 325 students this year, thus the entire senior class could not attend Prom. No dates other than Twinsburg High School Seniors could attend. I am in favor of this option:

5 parents responded favorably

7 seniors responded favorably

With eight (8) students per table and moderate space between students, 288 students could attend Prom. The senior class has 325 students this year, thus the entire senior class could not attend Prom. No dates other than Twinsburg High School Seniors could attend. I am in favor of this option:

19 parents responded favorably

7 seniors responded favorably

With ten (10) students per table and limited space between students, the entire senior class could attend Prom. The senior class has 325 students this year, thus the entire senior class could not attend Prom. No dates other than Twinsburg High School Seniors could attend. I am in favor of this option:

67 parents responded favorably

19 seniors responded favorably

I am not in favor of any of these options:

31 parents responded favorably

11 seniors responded favorably

Given the above data, and with the review of our Prom plan by the Summit County Public Health Department, there will be ten (10) students per table and limited space between students. More specific details regarding Prom 2021 will be provided by Dr. Hebert and our Senior Class Advisor Ms. Brittany Hartory.

Finally, this afternoon, superintendents in Ohio were asked to provide our interest in engaging in a



vaccine roll-out for students ages 16-18. I anticipate that this vaccine roll-out will occur on our campus in partnership with a local provider such as the Summit County Public Health Department or a private retail provider such as Discount Drug Mart who assisted with our Vaccination Clinics for our staff members. As more details become known, I will share the information with you.
