#### 12-079 Waiver of BMI

That the Twinsburg Board of Education directs the Superintendent to seek a waiver regarding the requirements set forth in Section 3313.67(A) of the Ohio Revised Code, from the Ohio Department of Education for the 2011-2012 school year. These requirements mandate kindergarten, third, fifth and ninth grade students be screened for body mass index and weight status category prior to the first day of May each school year.

#### 12-080 Academic Standards

That the Twinsburg Board of Education approves the adoption of the 2010 Ohio Department of Education (ODE) Standards for English Language Arts, Mathematics, Science, and Social Studies. English Language Arts and Math are considered national "Common Core Standards"; Science and Social Studies are considered revised "ODE Standards." These academic standards will be used in conjunction with the current Twinsburg Board-approved courses of study based on the current standards during a transition period working toward full implementation during the 2014-2015 school year. #### 12-081 **Student Trips**

That the Twinsburg Board of Education approves an Overnight/Extended Student Trip for the Varsity Baseball Team to travel to Somerset, Pennsylvania on April 9 through April 10, 2012, for baseball competition, as sent to board under separate cover. This trip is paid for by the students.

#### 12-082 **Student Trips**

#### 12-086 Adoption – Math Series

That the Twinsburg Board of Education adopts and purchases Houghton Mifflin Harcourt's *Go Math* c.2012, a new series for math instruction for Kindergarten through grade 6, as recommended by the District Curriculum/Technology Committee. The six-year proposal for the consumable Student Edition and Practice Book bundle is approximately \$174,000, discounted from \$397,000. The proposal also includes extensive teacher support materials, online student and teacher editions, online intervention and challenge resources for students, interactive white board lessons, and access to "Destination Math", a full supplemental intervention online program. This is general fund expenditure. The proposal for the coordinating hands-on materials, entitled *Grab & Go Differentiated Centers* and *The Manipulative Kit* for each classroom, is approximately \$30,000, discounted from \$39,100. This is a Permanent Improvement fund expenditure.

#### 12-087 Accept Donation

That the Twinsburg Board of Education accepts a donation of thirty-eight (38) flat screen monitors for the technology department from Emdeon, 2045 Midway Drive, Twinsburg Oh 44087.

#### 12-089 Transportation Fee

That the Twinsburg Board of Education approves a Transportation Fee of \$1 per mile for the use of the Twinsburg City School District buses by outside organizations, effective February 16, 2012. This Transportation Fee is in addition to fuel and the salaries of the bus drivers already charged back to the outside organization. The Transportation Fee is a charge back for maintenance, insurance and wear on the buses. The Transportation Fee is part of the Twinsburg City School District's Operational Change Plan.
