- 2. AND FURTHER RESOLVE that the Superintendent and Treasurer do internal appropriation modifications whenever necessary under provisions of the Purchasing and other Financial Policies of the District and under Ohio Law;
- 3. AND FURTHER RESOLVE to appropriate a \$10,000 Service Fund account in 2024;
- 4. AND TO FURTHER RESOLVE to grant the Superintendent or her designee authority to file applications for all projects considered desirable for the Twinsburg City School District;
- 5. AND FURTHER RESOLVE to authorize the signature of the Treasurer, or the facsimile thereof, to be used on all checks and warrants;
- 6. AND FURTHER RESOLVE to designate the Superintendent or her designee as purchasing agent for the Twinsburg City School District for 2024;

- 7. AND FURTHER RESOLVE to authorize the Treasurer to invest funds, whenever practical as permitted by law, either in short-term or long-term investments and to give a report to the Board;
- 8. AND FURTHER RESOLVE to authorize the Treasurer to provide payments to employees for salaries and expenses and to suppliers for goods and services within appropriations (a check register will be presented to the Board);
- 9. AND FURTHER RESOLVE that the Treasurer's name will appear on all active accounts;
- AND FURTHER RESOLVE that the budgetary level of authority and legal level of 10. appropriations to be at Fund Level for the General Fund and all other Funds:

Time: The board meetings will be called to order at 7 o'clock p.m.

Place: The meetings of the Board of Education will be held at the Twinsburg Government Center or at Twinsburg High School (Auditorium or LGI Room) when the Twinsburg Government Center is not available.

- 13. AND FURTHER RESOLVE that the Twinsburg Board of Education accepts any and all federal and state grant monies available to the district and to authorize the participation of staff members in any grant programs available to the district during the school year 2024-2025;
- 14. AND FURTHER RESOLVE to authorize the Superintendent to employ personnel and accept resignations; as needed during calendar year 2024. Such employments and resignations will be reviewed by the Board of Education at its next regularly scheduled meeting;
- 15. AND FURTHER RESOLVE to authorize the Treasurer to direct Board-approved legal counsel to file original complaints against the valuation of commercial properties, to file counter-complaints against the valuation of commercial properties, to present evidence relating to the value of such properties at hearing or trial, to appeal

decisions of the Summit County Board of Revision and the Ohio Board of Tax Appeals, to participate in any other real property tax appeal, to enter into settlement agreements and stipulations of value related to real property tax cases, and to take such other actions as are necessary to protect the best interests of the Twinsburg City School District in matters of real property taxation, provided that the Treasurer give regular updates regarding such actions to the Board of Education and Superintendent, for a one-year period, beginning January 1, 2024;

- 16. AND FURTHER RESOLVE to recommend that the Twinsburg Board of Education appoint the Superintendent, Treasurer, Business Manager and Peters, Kalail & Markakis Co., L.P.A., as representatives to the Tax Incentive Review Council meetings at Summit County Department of Economic Development and at the City of Twinsburg;
