It came to my attention last Thursday that many of you, as well as other residents, received a letter in the US Mail that purports to represent the Twinsburg City School District. This letter not only includes information about Issue 33, the District's proposed Bond Levy, it also includes information about the City of Twinsburg's Issue 19. This letter **was not** distributed by the Twinsburg City School District. There are erroneous statements in that letter and it is unfortunate that an individual or group of individuals find it necessary to confuse our residents with misleading information.

Refundable Tax Credits

Ohio families can benefit from refundable tax credits. Tax credits help working taxpayers. However, there are many taxpayers who are eligible for these tax credits but don't claim them. For example, the Internal Revenue Service (IRS) estimates that while four out of every five eligible taxpayers claim the Earned Income Tax Credit, there are millions of eligible taxpayers who do not. The IRS asked us to distribute this information for all taxpayers filing on extension this year and for all eligible taxpayers getting ready for filing season 2025.
