09-241 **Dodge Cooling Tower**

Mr. Shebeck moved and Mr. Andrews seconded that the Twinsburg Board of Education approves installation of the replacement cooling tower at Dodge Intermediate School. All work to be performed by Gardiner Trane, 31200 Bainbridge Road, Solon, OH per the contracts approved by the State Term Schedule Procurement program, Schedule Number 7763200306, in the amount of \$77,224, to be paid out of Permanent Improvement funds; upon the recommendation of the Superintendent.
